Gifts of Will - Bequest Language Suggestions

Leaving a bequest in your Will is a great way of giving back to charities you support in a meaningful and impactful way. Amherstburg Community Services provides sample charitable bequest clauses for your reference and use. We advise that you consult your legal advisors, financial planners and family members when considering including any such clauses or other gifts to ACS in your Will.

General Bequest Clause

This basic clause states that you wish to leave an unrestricted gift to Amherstburg Community Services. Any gift received would be allocated in the most appropriate and necessary areas of ACS, as determined by ACS.

I give (my whole estate) or (specific percentage of my estate) or (specific assets) or (the residue of my estate) or (the sum of \$_____) to Amherstburg Community Services for its general purposes. I declare that the receipt of Amherstburg Community Services will be sufficient discharge to my trustees.

Specific Bequest Clause

This clause states that you wish to leave a gift to Amherstburg Community Services, with the intent that it be allocated in a specified way. However, because this clause is not binding, ACS would be free to allocate this gift elsewhere, if the organization deems it appropriate or necessary. Please note, that ACS provides services that match the needs of the community – it may happen, and has happened, that the community no longer requires a specific program or service currently offered by ACS, resulting in ACS no longer offering said program or service.

I give (my whole estate) or (specific percentage of my estate) or (specific assets) or (the residue of my estate) or (the sum of \$_____) to Amherstburg Community Services for its general purposes. I express the wish, but without creating any binding trust that if practicable this gift be applied to (state general purposes as widely as possible). I declare that the receipt of Amherstburg Community Services will be sufficient discharge to my trustees.

Contingency Bequest Clause

This clause ensures that if the primary intention of your Will cannot be met, your estate will be passed on to ACS rather than unintended beneficiaries, including the government.

I declare that the receipt of Amherstburg Community Services will be sufficient discharge to my trustees.
